IN 2017 60 SAFE T HOMES, HIGHLY MODIFIED GRAIN BINS, WERE SHIPPED, ASSEMBLED AND USED FOR SHELTER FOR DISPLACED FAMILIES AND INDIVIDUALS, BRINGING THE TOTAL SAFE T HOMES IN HAITI TO NEARLY 275, WITH SOME OF THESE HOMES BEING DELIVERED TO OTHER ORGANIZATIONS WORKING IN HAITI. THERE ARE 70 HOMES AT THE VILLAGE OF HOPE (350 RESIDENTS), 18 HOMES AT JOHN 3:16 VILLAGE IN CAMP PERRIN (50 RESIDENTS), 18 HOMES AT JAMES 1:27 VILLAGE (16 BABIES AND 7 WIDOWS), 15 AT JOSHUA HOUSE (67 ORPHAN BOYS) AND 8 AT THE CENTER OF HELP (40 ORPHAN CHILDREN). A NEW VILLAGE IN LABRISE, HAITI WAS REBUILT WITH 15 HOMES THAT WERE DESTROYED BY HURRICANE MATTHEW. THERE ARE 10 IN PERU AT THE HIDDEN CREEKS BIBLE CAMP, USED AS THE BOYS AND GIRLS CABINS, WHEN THEY COME TO CAMP. THERE ARE 10 IN KENYA USED FOR MISSIONARY

IN HAITI, THE CONSOLATION CENTER HOUSED 85 ORPHAN GIRLS, THE JOSHUA HOUSE SERVED 67 ORPHAN BOYS AND THE CENTRE EDUCATIF LE RECONFORT SCHOOL EDUCATED NEARLY 500 BOYS AND GIRLS FROM OUR ORPHANAGES AND THE SURROUNDING COMMUNITY. IN ADDITION, THE CENTER OF HELP HAD 35 ORPHANED BOYS AND GIRLS, THE JAMES 1:27 VILLAGE HOUSED 16 BABIES AND 7 WIDOWS, THE ILE A VACHE SPECIAL NEEDS ORPHANAGE HAS 30 RESIDENTS AND THE CITADEL ORPHANAGE HAS 20 CHILDREN. CONSTRUCTION OF A NEW CHURCH NEAR THE CONSOLATION CENTER IN HAITI BEGAN IN 2017. THIS CHURCH WILL NOT ONLY SERVE THE CHILDREN LIVING IN OUR ORPHANAGES, BUT ALSO THE SURROUNDING COMMUNITY. PASTOR VIONEL SERVES THIS CONGREGATION WHICH IS CURRENTLY MEETING IN THE COMMUNITY CENTER AT THE CONSOLATION CENTER. THE CENTRE DE VIE CHURCH IN LES CAYES, HAITI IS THRIVING WITH OVER 450 PEOPLE IN THE CONGREGATION WHERE THEY HAVE HAD TO ADD A SECOND SERVICE TO ACCOMMODATE EVERYONE. OUR FIRST MISSIONARIES, A YOUNG COUPLE AND THEIR CHILDREN BEGAN SERVING IN HAITI IN JULY OF 2017. IN INDIA, WHERE WE SUPPORT TO MAIN PASTORS, OVER 500 PEOPLE WERE BAPTIZED. OUR TWO MAIN PASTORS TRAIN AND ENCOURAGE ANOTHER 75 PASTORS WHO SHARE THE GOSPEL IN REMOTE TRIBAL AREAS, STARTING NEW CHURCHES. THE INHERITANCE
